

prohibitions. May we become among the muttageen. On this blessed day, let us listen and ponder upon a khutbah entitled: "Knowing The Sharee 'ah Criminal Code"

Indeed, Allah Subhaanahu Wata'aala has created mankind having various ethnicities, looks, culture, different level of thinking and emotions. Hence, Allah Subhaanahu Wata'aala has

revealed the complete Sharee 'ah for the entire mankind, in ensuring happiness in this world and the Hereafter. Allah Subhaanahu Wata'aala mentions in al-Qur'an:

"And there is for you in legal retribution [saving of life, O you [people] of understanding, that you may become righteous." (al-Bagarah 2:179) Verily, Allah Subhaanahu Wata'aala is All-Knowing of all the circumstances and the need of mankind living in a society. Furthermore, Allah Subhaanahu Wata'aala who is The Most Merciful and

The Most Compassionate will ensure that the human life will not become destroyed without having guidance and guidelines from Him.

That is why the Islamic Sharee 'ah was revealed with perfection, covering all aspects of lives from matters pertaining to worship to aspects of social, legal, economy, finance,

governance, international relations, and many more. What is actually meant by the Sharee 'ah Criminal Code? Sharee'ah Criminal Code are laws pertaining to offenses

related to life, physical body, dignity, religion, lineage, and personal wealth, all according to the Islamic rulings. In reality, the Sharee 'ah Criminal Code has already been implemented with success during the time of Rasulullah صلى الله the Rightly-Guided Caliphs, the dynasties of the Umayyad, 'Abbasid, Andalusia, and the Ottoman Empire, where

citizens lived in peace and enjoyed justice in their ruling government. History also has recorded its implementation by the Malay Sultanate of Malacca whom had control of trades

between the East and the West at that time, and also the sultanate of Terengganu, Perak, and Pasai, all from the Malay ancestry once upon a time ago, prior to being colonized by Western

colonialists. Its implementation has proven and manifested peace and happiness. As an example, in the 24 years of implementation by the Saudi government, only 16 people

were actually sentenced for the cutting of the hand for stealing. Even in its early stages, the Bruneian government had felt positive effects after implementing the first phase of their

#### Sharee'ah Criminal Code. The Sharee 'ah Criminal Code is comprised of three aspects, namely: 1. Laws pertaining to Qisaas (retribution) offenses. This is related to murder or

injury that can be reciprocated, if it involves offences pertaining to Qisaas and diyah (blood money). 2. Hudood laws. There are six criminal offences that is punishable

by mandatory sentence namely fornication and sodomy, accusing someone of adultery (qazaf), consuming intoxicants, stealing, and apostasy.

3. Ta'zir laws It refers to criminal offenses other than offences relating to Qisaas and hudud, where its punishment will be determined according to suitability by the ruling authority.

The implementation of the Sharee'ah Criminal Code is in line with the command of Allah Subhaanahu Wata'aala and the guidance of Rasulullah صلى الله to all of us. Regarding fornication,

Allah Subhaanahu Wata'aala mentions in al-Qur'an: "The [unmarried] woman or [unmarried] man found guilty of sexual intercourse - lash each one of them

with a hundred lashes, and do not be taken by pity for them in the religion of Allah, if you should believe in Allah and the Last Day.

# And let a group of the believers witness their punishment."

(an-Noor 24:2)

For qazaf-related offenses, which is accusing others of committing adultery, Allah Subhaanahu Wata'aala mentions in al-Qur'an: "And those who accuse chaste women and then do

#### not produce four witnesses - lash them with eighty lashes and do not accept from them testimony ever after. And those are the defiantly disobedient." (an-Noor 24:4)

Regarding stealing, Allah Subhaanahu Wata'aala mentions in al-Qur'an: "[As for] the thief, the male and the female, amputate their hands in recompense for what they committed as

### a deterrent [punishment] from Allah. And Allah is Exalted in Might and Wise."

(al-Maa'idah 5:38)

For committing apostasy, it was narrated from 'Ikrimah radiyAllaahu'anh who mentioned that ibn 'Abbaas radiyAllaahu 'anhuma stated that Rasulullah عليه وسلم said:

## "Whoever changed his religion (Islam), then kill him."

(al-Bukhaari)

In safeguarding the intellect ('aql), Islam strictly prohibits its adherents from consuming intoxicants. Such offense is punishable with 40 lashes as mentioned in the hadeeth of Anas bin Maalik

radiyAllaahu'anh: "The Prophet (عليه وسلم) beat a drunk with palm-leaf stalks and shoes. And Abu Bakr gave (such a sinner) forty lashes." (al-Bukhaari)

Similarly for all other offenses, they all would have religious basis in their rulings, whether from al-Qur'an, Hadeeth, and others sources of Islamic

After we have understood upon the benefits of implementing the Sharee 'ah Criminal Code, then it is unbecoming for us as Muslims to omit Allah's Laws and His Messenger in

these matters, that we have the audacity to accept manmade laws instead. It is very unfortunate that there are Muslims claiming that the Criminal Code revealed by Allah Subhaanahu

Wata'aala is no longer suitable, outdated. Even more unfortunate are those that boldly state that Islamic law is unjust. How is such when we would pledge with our utterance every time we

pray:

My prayer, and my service of sacrifice, my life and my death are all for Allah, the Lord of the Universe. Allah Subhaanahu Wata'aala has reminded us

in al-Qur'an: "It is not for a believing man or a believing woman, when Allah and His Messenger have decided a matter, that they should [thereafter] have any

choice about their affair. And whoever disobeys Allah and His Messenger has certainly strayed into clear error." (al-Ahzaab 33:36)

Let us realize that the crime statistics today has not reduced even though we are using manmade legislations. Furthermore, the criminal offender will repeat the same offense after getting released

from prison. They are unafraid and undaunted from repeating the same criminal act. Let us ponder upon the golden history of Islam, when the Sharee 'ah was

implemented full-blown by the Islamic government, where human civilization rapidly developed in various fields, the society lived in peace, science and technology went forward

through great leaps and bounds, the glory of knowledge crossed boundaries that it changed civilizations in Europe and the West.

In concluding today's khutbah, the important concerns and recommendations for us would be: 1. The Muslim umah should get to know,

comprehend, and learn the Sharee'ah Criminal Code that was divinely revealed by Allah Subhaanahu Wata'aala.

2. The Muslim umah should not fear the

implementation of the Sharee 'ah Criminal Code for its effectiveness has been proven in the aspects of justice, prosperity, and civilization for the humankind.

3. The Muslim ummah is obligated to have imaan with full certainty upon everything promised by Allah Subhaanahu Wata'aala in attaining a better life that is full of

## barakah and pleasing to Allah Subhaanahu Wata'aala.


"So how [will it be] when We bring from every nation a witness and we bring you, [O Muhammad] against these [people] as a witness?" (an-Nisaa' 4:41)
