

I call upon all of us to altogether strive in increasing our taqwa of Allah Subhaanahu Wa Ta'aala by performing all of His Commands and leaving out all of

His prohibitions. Let us give full attention to the sermon that is to be delivered. Do not speak to others and do not toy around with our cellphones. May this khutbah benefit us all.

In conjunction with the 78th birthday of His **Highness the Sultan** of Selangor on the 11th of December 2023, let us reflect upon the khutbah that is to be conveyed titled

Article 3(2) of the Federal Constitution stipulates the Ruler as the Head of Islam in his respective state, to the extent that is recognized and declared by the state constitution.

provisioned As and stipulated in the Laws of the Constitution of Selangor 1959, Article 48, His Majesty the Sultan of Selangor is the Head of Religion of the State and that he can create

laws to govern the affairs of the religion of Islam and established Majlis Agama Islam Selangor (Selangor Islamic **Religious Council, MAIS)** to aid and advice His **Majesty in all matters**

pertaining to the religion of Islam.

Allah Subhaanahu Wa Ta'aala mentions in verse 165 of Soorah al-An'aam that was recited at the beginning of the khutbah:

"And it is He who has made you successors upon the earth and has raised some of you above others in degrees [of rank] that He may try you

through what He has given you. Indeed, your Lord is swift in penalty; but indeed, He is Forgiving and Merciful."

In accordance with that provision, the Administration of the **Religion of Islam (state of** Selangor) Enactment 2003 has been legislated to allocate jurisdiction and responsibilities to

MAIS, as well as other Islamic agencies, upon the affairs of Islam and the Muslims in the state of Selangor.

MAIS was established under Section 4(1),

carrying the role of an body to His advisory Highness the Sultan, and as the primary authority after His Majesty the Sultan in matters relating to

Selangor, Islam in except matters for regarding the determination of Shara' Rulings the and **Administration** of Justice.

The Enactment also allocates the for the function of MAIS in aiding and advicing His Majesty the Sultan in matters relating to Islamic affairs, MAIS' responsibilities and

powers in governing Islamic affairs within the state. In implementing the policies and power of MAIS, Jabatan Agama Islam Selangor (Selangor Religious Islamic **Department**, JAIS)

was established by the state government to aid in the implementation of MAIS' policies and powers.

While matters pertaining to the implementation of Islamic judicial functions

and the administration of justice, MAIS has the role of advising His Highness the Sultan in the appointments of Chief Sharee'ah Court Judge, Sharee'ah Appeal Court Judges, and

Sharee'ah High Court Judges, all under Section 56, 57, and 58, within the same Enactment. All matters regarding the establishment the of Court and Sharee'ah **Court Judge**

appointments must be done through MAIS.

Furthermore, in matters pertaining to *Shara'* Rulings, His Majesty the Sultan is authorized to

appoint the Mufti and **Deputy Mufti for the state** of Selangor in advising His Majesty the Sultan with regard to all matters of Sharee'ah Law. Section 46 stipulates that MAIS has the authority to

appoint members of the Fatwa Committee. The Fatwa Committee has the power to issue fataawa on any matters that have yet to be determined or those that are controversial with

regards to the Shara' Rulings, as provisioned under Section 47 of the Administration of the **Religion of Islam (state** of Selangor) Enactment 2003.

The administration of Islamic affairs within the state government is through the Chairman of Permanent the **Committee for Islamic Affairs (state government Exco)** who functions as

the liaison officer between MAIS and the state government for the following matters:

1. Providing feedback and ensure that MAIS' policies regarding Islamic affairs can be implemented by the state government.

2. To ensure that the provision from the state government to JAIS, the Selangor Mufti **Department**, and the

Sharee'ah Courts are utilized appropriately, in accordance with the purpose of the allocation given in the state of Selangor.

3. Providing feedback policy regarding formulation and its implementation pertaining Islamic affairs in the state of Selangor.

His Royal Highness the Sultan of Selangor, Sultan Sharafuddin Idris Shah al-Haj, since taking the reign of the government has been concerned very regarding the

implementation of Islamic principles, entities that are threatening the holiness of Islam, and ensuring the Muslims are always empowering their strength and unity. All of these matters have been

carried out with very thorough consideration, equality, and justice for all residents. This adheres to what Allah Subhaanahu Wa Ta'aala mentions in verse 26 of Soorah Sad:

"[We said], "O David, indeed We have made you a successor upon the earth, so judge between the people in truth and do not follow [your own] desire, as it will lead you astray from the way of Allah.""

The Sultan of Selangor has instructed MAIS to defend the use of the kalimah (word) "Allah" and firmly asserted in his decree for all non-Muslim Selangor residents to conform and abide by the

prohibition of using the kalimah Allah as stipulated in the Non-**Islamic Religions (Control** of Propagation Among **Muslims) Enactment 1988** that was gazetted on July 7th, 1988.

This includes the usage of several more terms that are mentioned in the Religions **Non-Islamic** Enactment for the purpose of commercial use and naming a building or business

area. His Majesty further decreed that the word Allah cannot be utilized wrongly or used to refer to other than The One and Only Almighty God, which is

the very core of belief for the Muslim *ummah*.

al-Ghazzaali Imaam mentioned in his book al-Iqtisaad fee all'tiqaad:

His Majesty is very concerned regarding the importance of unity and brotherhood among the **Muslims in Selangor. He** decreed during the Award Ceremony for the **Certification of**

Appointment for Masjid Administrators and Imams in Selangor for the term 2023-2025 at **Istana Alam Shah:**

"I do not like for the masjid to be used as an arena for politics and political party's propaganda. The masjid must be a place that is free from any influence and elements of party politics. Religious

lectures and classes conducted at the masjid must not be turned into a platform to insult, backbite, slander, and curse anyone. If this happens, then it will

prolonged cause conflict and will sever bond the of brotherhood among Muslims."

His Majesty's concern in strengthening the unity of the Muslims and preserving the harmony within the community in the state of Selangor has been revealed through sermons that were

delivered on the mimbar (pulpit) of masaajid. For example, His Highness had repeated his reminder in a khutbah dated 21st July 2023, where the Sultan made mention upon the danger

of backbiting, insulting, reviling, and cursing, what more with slandering where it is from among the major sins, deemed as worse than killing.

The Sultan of Selangor, the who also is Chairperson of the National Council for Islamic Affairs (MKI), is worried that if the heinous practice of hurling fitnah and

swearing are not curbed, the division within the ummah Muslim specifically in Selangor will become increasingly and severe uncontrollable.

Narrated Tameem ad-Daariy radiyAllaahu 'anh that the Prophet Said:

"The Religion İS sincerity." We said, "To whom?" He said "To Allah, to His Book, To His Messenger, and to the leaders of the Muslims and their masses."

Imaam al-Mawardi wrote in his book *al-Ahkaam as-Sultaaniyyah:*

"Imaamah (leadership) was formed to replace the prophetic function in order to maintain religion and regulate the world."

conclusion, the In governance of Islamic affairs in Selangor is based on the Laws of the **Constitution of Selangor** 1959 that is led by His Royal Highness the Sultan, aided by MAIS

and the State Executive **Council (MMKN) through** various state agencies such as JAIS, Selangor Mufti Department, and Sharee'ah Selangor Judicial Department. The implementation of the

responsibilities and functions of each of those agencies have been provisioned in the Administration of the **Religion of Islam (state** of Selangor) Enactment 2003.

As the scholars mentioned:

الناسُ عَلَى دِينِ مُلُوكِهِمُ

"The people are upon the religion of their leaders."

This statement succinctly manifests the reality of the society and this is what actually happens in most human lives. Hence, with the Sultan as role model, it will certainly have a profound effect

upon his subjects.

To end this khutbah, let altogether US internalize upon its lessons as follows:

is waajib **1**. It (obligatory) upon the Muslim ummah to strengthen its imaan (faith) in Allah and His Messenger.

2. It is waajib upon the Muslim ummah to obey the commands of a just ruler, especially in the affairs of the religion.

3. It is waajib for the Muslim ummah to emulate the personality of Rasululah

"Allah has promised those who have believed among you and done righteous deeds that He will surely grant them succession [to authority] upon the earth just as He granted it to those before

them and that He will surely establish for them [therein] their religion which He has preferred for them and that He will surely substitute for them, after their fear, security, [for] they

worship Me, not associating anything with Me. But whoever disbelieves after that then those are the defiantly disobedient."

(Soorah an-Noor 24:55)
